## **OBJECTIVES**

- To introduce the principles and objectives of land stewardship
- To offer basic methodologies and knowledge on land stewardship tools, through the presentation of case studies
- To provide support to the learning process by students, adapted to their knowledge and interests

## **METHODOLOGY**

The course is based on **online learning methodologies**, using the online platform of the University of Vic. This educative platform allows students to have access to the documentation of the course, interact with other students through forums, and send consultations to the professors.

The professors will upload the documentation for each of the three modules of the course and the instructions for the associated exercises. During the course, students will present case studies of land stewardship, design a stewardship agreement, analyze methods and communication experiences, and funding opportunities for land stewardship.

Online forums will be set for discussion and exchange regarding the content of the modules and other subjects relevant to the course. Professors will also be available to students for questions and issues during the course.

The progress of the students will be evaluated along the course by the professors through the participation on the debate forums and the exercises provided for every module.
